: Rs. 3,000/- in cash or through SBI, Paona Bazar Branch A/c. No. 32887073471 and IFSC Code: SBIN0007440 be paid to MABA.

Rs. 300/- per Boxer

**Competition Format** 

: Elite & Under-19 three (3) rounds of three (3) minutes, one (1) Minute rest Between rounds, Under-17 (3) rounds of three (3) minutes one (1) minute rest Between rounds, Under-15 (3) rounds of three (1.5) minutes one (1) minute rest Between rounds World Boxing 10 points must scoring system shall be followed. Championship will be conducted as per World Boxing, BFI AOB Technical & Competition Rules.

No protest is allowed. The Coach is responsible for boxer behaviour both can be suspended for unsportsmanlike behaviour.

**Eligibility** 

Entries will be accepted on receipt of Entry by Number & Entry by Name duly signed by the President/Secretary of the affiliated Unit/District in the given format of MABA.

Boxers approved I.D No. of MABA is mandatory.

District unit will not be allowed to participate unless fee is being paid to MABA.

Medical & Weigh-in

: Daily weigh-in and medical examination will be held at the venue from 7:00 – 8:00 am. hrs for those boxers who are drawn to box on those respective days from 21<sup>th</sup> to 27<sup>th</sup> July 2025. Boxers must present themselves clean shaven and without any body piercing and any accessories are not allowed.

Boxers who are already registered with MABA must carry MABA Medical book other than BFI Medical book at the time of weigh-in.

Boxers who do not have MABA medical book can be obtained from the office of MABA by paying Rs. 300/-

#### **AGE FRAUD POLICY**

1. OBJECTIVE

: The Boxing Federation of India (BFI) and Manipur Amateur Boxing Association (MABA) are committed to ensuring fair play and integrity in the sport of boxing. This Age Fraud Policy aims to prevent, detect, and address age fraud in all levels of boxing competitions conducted under the aegis of MABA.

2. SCOPE

- : This policy applies to all boxers, coaches, officials, and affiliated units participating in any MABA sanctioned event, competition or selection trial at the national, zonal or state level.
- 3. DEFINITION OF AGE FRAUD
- : Age fraud refers to the act of misrepresenting one's age through false documentation or other deceptive means in order to gain an unfair advantage or qualify for an age-specific competition category.
- 4. SUBMISSION OF AGE PROOF
- : All participants must submit authentic and verifiable proof of age at the time of registration. Acceptable documents include:
  - Birth Certificate issued by a Municipal Authority or equivalent government body (Registered within 2 years of birth of the Athlete).
  - Aadhar Card along with Aadhar History.
  - Passport.
  - Certificate from a recognized school (only as secondary evidence).

# If any discrepancies are found in the documents, the Athlete shall be required to provide additional documents including:

- Entry record details of the birth from the hospital or Primary Health Centre (PHC). If recorded in an official register, an attested copy must be provided, including the preceding, current, and following pages to demonstrate the authenticity and continuity of the records.
- COVID-19 Vaccination Certificates issued by the Government of India.
- School Report Cards from Nursery to 5th Standard (with clearly mentioned date of birth).
- Ration Card (with clearly mentioned date of birth).
- 5. VERIFICATION AND INVESTIGATION
- The MABA reserves the right to verify the authenticity of age documents submitted by any participant.

- Any suspicion or complaint regarding age fraud shall be investigated by a designated Age Verification Committee constituted by MABA.
- Upon receipt of a complaint or on its own motion, the Age Verification Committee shall initiate an inquiry into any suspected case of age fraud.
- Before taking a final decision, the Committee shall give the concerned participant/athlete an opportunity to be heard and to present his/her case, including submission of supporting documents or explanations.

6. DISCIPLINARY ACTION

#### : If a boxer is found guilty of age fraud:

- The boxer shall be disqualified from the competition and may face a ban of up to three (3) years from all MABA competitions.
- The coach, manager, or any official found complicit may also be subject to disciplinary action, including suspension.
- The concerned affiliated unit may face penalties, including monetary fines or suspension, if found negligent or complicit.
- The boxer may be eligible for a reduction of up to 1.5 years in the period of ineligibility if they provide credible information implicating any coach or official involved in, or assisting with, the commission of age fraud.

7. APPEAL MECHANISM

Any person aggrieved by a decision made under this policy may file an appeal to the Youth and Age Fraud Commission within 15 days from the date of the order, by submitting a written request via email to the official email address: mabamanipur@gmail.com. The decision of the Youth and Age Fraud Commission shall be final and binding on all parties.

#### **8. PREVENTIVE MEASURES**

- All affiliated units shall conduct awareness programs on age fraud for athletes and stakeholders.
- All affiliated units are directed to verify the age documents of their boxers diligently before sending entries.
- Team Coaches/Team Mangers and Boxers are not allowed to wear any other uniforms except their concerned Unit/District identity.
- 10. All boxers must possess their own Gum shield (not of red or partially red colour), boy boxers must wear a cub protector and may additionally wear a jock-strap.
- 11. Every weigh-in before every bout, the Boxers weight should not exceed the maximum of the Boxers weight class nor be below the minimum of Boxers weight class.
- 12. Any types of body piercing and body accessories is not allowed to be worn during the bout and Medical Examination & weigh-in.

- 13. MABA will provide Boxing Gloves to all the Boxers for their respective bouts.
- 14. Fooding and lodging shall provide by the concern Unit/District themselves.
- 15. Persons accompanying the team as Manager/Coach will not be permitted to officiate as TO/RJ in the Championship.
- 16. Age estimation Certificate issued by RIMS, JNIMS or any Government Hospital/format of Ministry of Youth Affairs & Sports is mandatory except the Elite Boxer.
